UNIT SHARES HELD BY THE AFFILIATES HAVE A UNIT VALUE BASED UPON THE FAIR VALUE OF THE NET ASSETS OF THE BOR ENDOWMENT DIVIDED BY THE TOTAL NUMBER OF UNIT SHARES OUTSTANDING. THE BOR ENDOWMENT PROVIDES FOR ANNUAL DISTRIBUTIONS TO THE UNION AND AFFILIATES IN ACCORDANCE WITH THE UNION'S APPROVED SPENDING POLICY, PRORATED IN ACCORDANCE WITH THE PERCENTAGE OF THE FAIR VALUE OF EACH UNIT SHARE. THE INVESTMENT GOAL OF THE BOR ENDOWMENT IS TO INVEST ASSETS IN A PRUDENT MANNER THAT WILL PRODUCE A REASONABLE DISTRIBUTION TO THE NATIONAL FOUNDATION AND AFFILIATED FOUNDATIONS AND PROVIDE LONG-TERM GROWTH IN VALUE OF THESE ASSETS.

THE UNION'S SHARE OF THIS ENDOWMENT IS SUBJECT TO CERTAIN WITHDRAWAL LIMITATIONS AS DISCLOSED IN THE BOR ENDOWMENT AGREEMENT. UNDER THE NATIONAL SPENDING POLICY, THE UNION RECEIVES A DISTRIBUTION EQUAL TO 4% OF THE THREE-YEAR AVERAGE UNIT VALUE OF THE FAIR VALUE OF INVESTMENTS AT THE BEGINNING OF EACH OF THE PRECEDING FISCAL YEARS. DISTRIBUTIONS ARE TYPICALLY IN THE FORM OF CASH OR ADDITIONAL UNIT SHARES OF THE FUND.
