## STATUS REPORT REGARDING PLAINTIFF-PETITIONERS PEREIRA BRITO AND AVILA LUCAS

As a supplement to paragraph 19 of the Affidavit of Sidra Vitale, Esq. with Regard to Gilberto Pereira Brito (filed under seal), counsel for the petitioners hereby report that, on June 17, 2019, the Hingham District Court dismissed the 2009 charge against Mr. Pereira Brito for driving with a suspended license. A copy of the docket reflecting the dismissal is attached as Exhibit A.

As a supplement to paragraph 15 of the Affidavit of Melanie M. Chaput, Esq. with Regard to Florentin Avila Lucas, counsel for petitioners hereby report that, at the hearing on June 18, 2019, the Immigration Judge indicated that he is reviewing the motion to suppress and opposition memoranda, and that he will issue a written order to schedule the next phase of the proceedings (either an evidentiary hearing on the motion, or a hearing for further removal proceedings).

Mr. Pereira Brito and Mr. Avila Lucas remain detained at the Plymouth County Correctional Facility.
