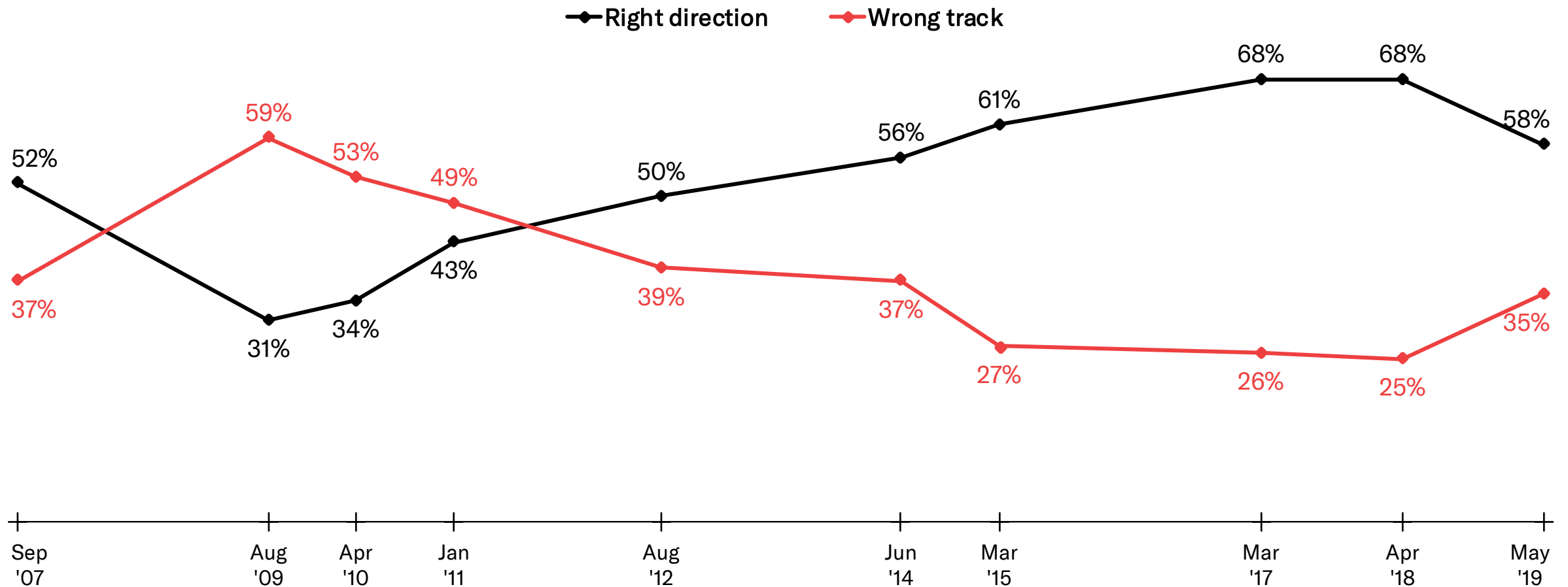

Project direction and analysis from Chris Anderson

Mode	Telephone survey conducted by trained professional interviewers from a central, monitored location; respondents were interviewed on cell phones and landlines
Sample	503 Massachusetts voters
Dates	May 22-29, 2019
Weights	Slight weights were applied to ensure the sample accurately reflects the demographic profile of the Massachusetts voter population
Margin of Error	±4% at the 95% confidence level for the entire sample; the margin of error for subgroups is higher
Note	Some data may not add up to 100% due to rounding



Most feel MA is on the right track, but that may be starting to change.

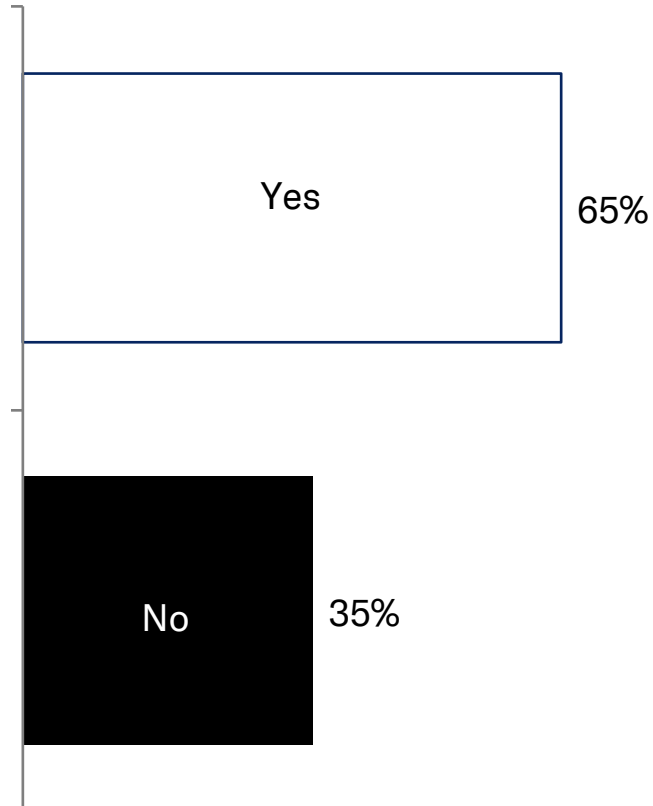


Q1: Next, do you feel things in Massachusetts are generally heading in the right direction, or do you feel things have gotten pretty seriously off on the wrong track?

Two-thirds have heard something recently about face recognition technology, and they are much more concerned than optimistic.

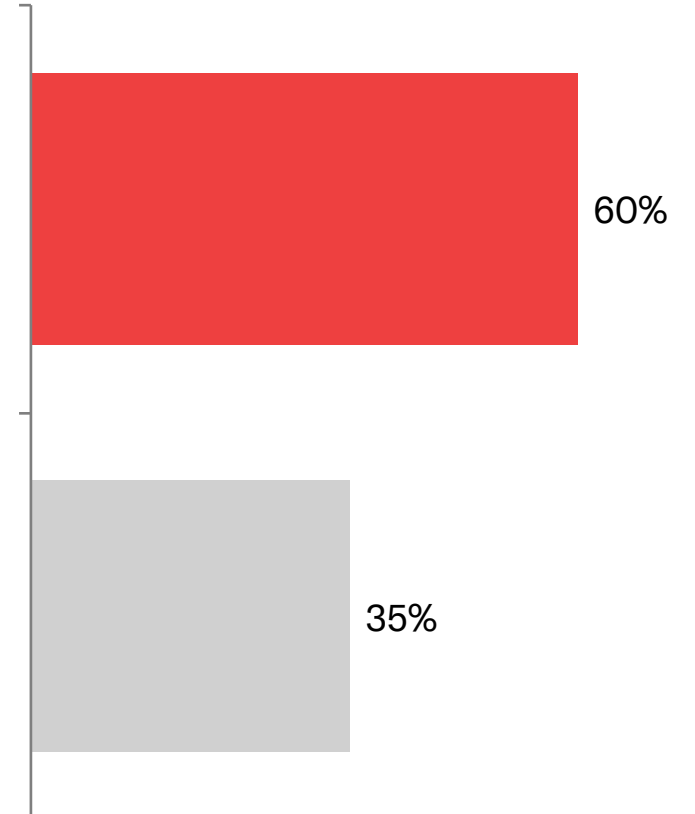
HEARD ABOUT FACE RECOGNITION SURVEILLANCE TECHNOLOGY

More **concerned** about potential misuses

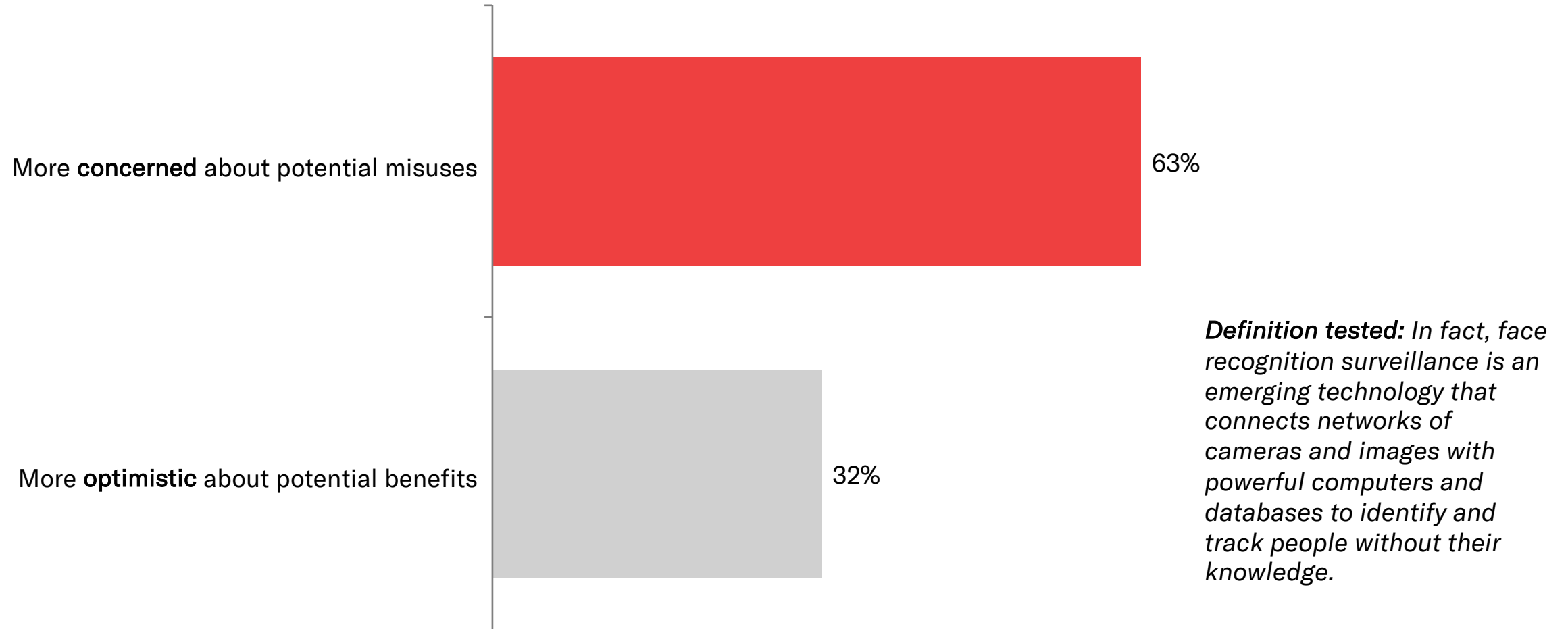
More **optimistic** about potential benefits

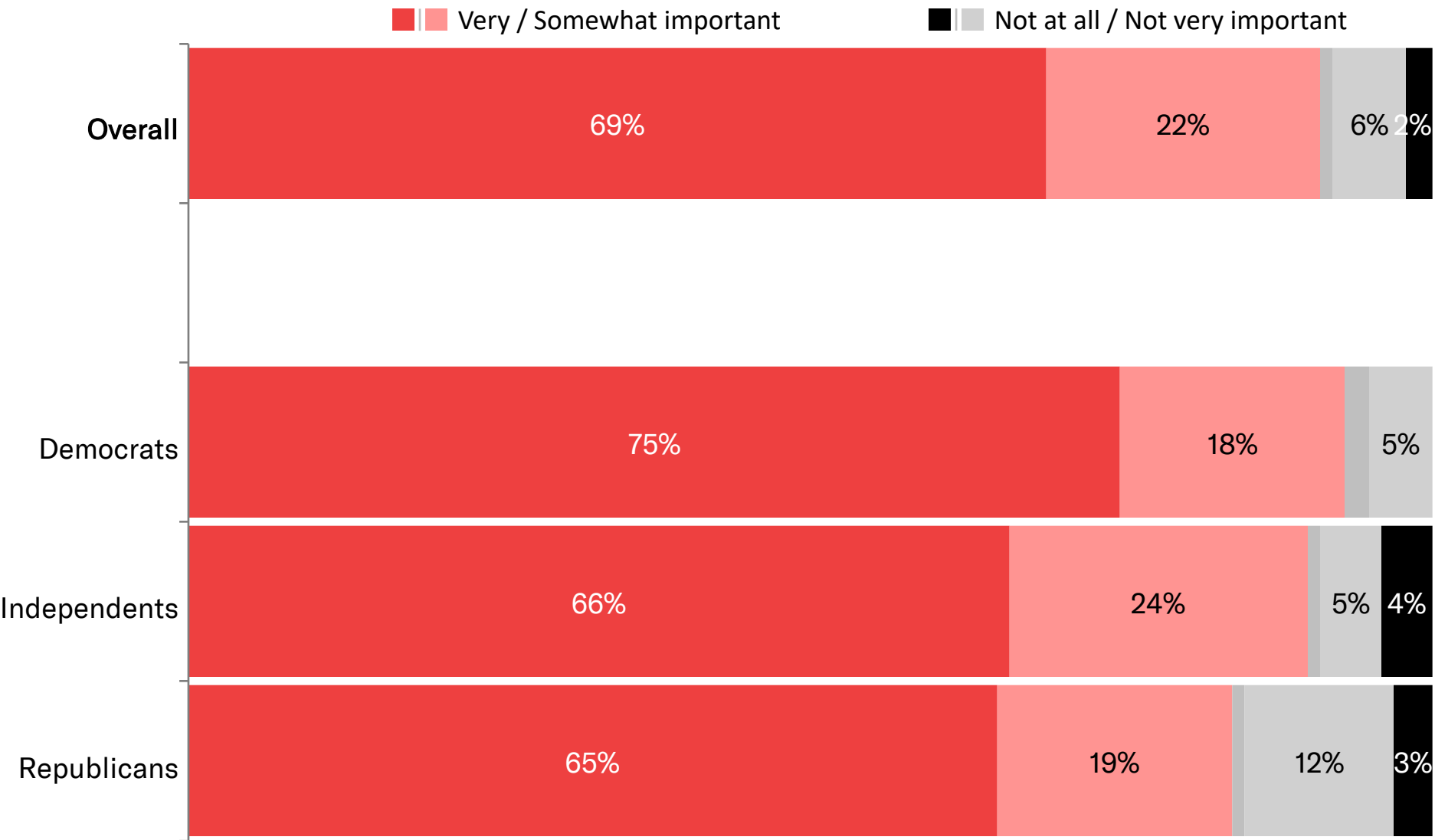
After hearing a definition, voters are more concerned about potential misuses than optimistic about benefits of facial recognition surveillance.

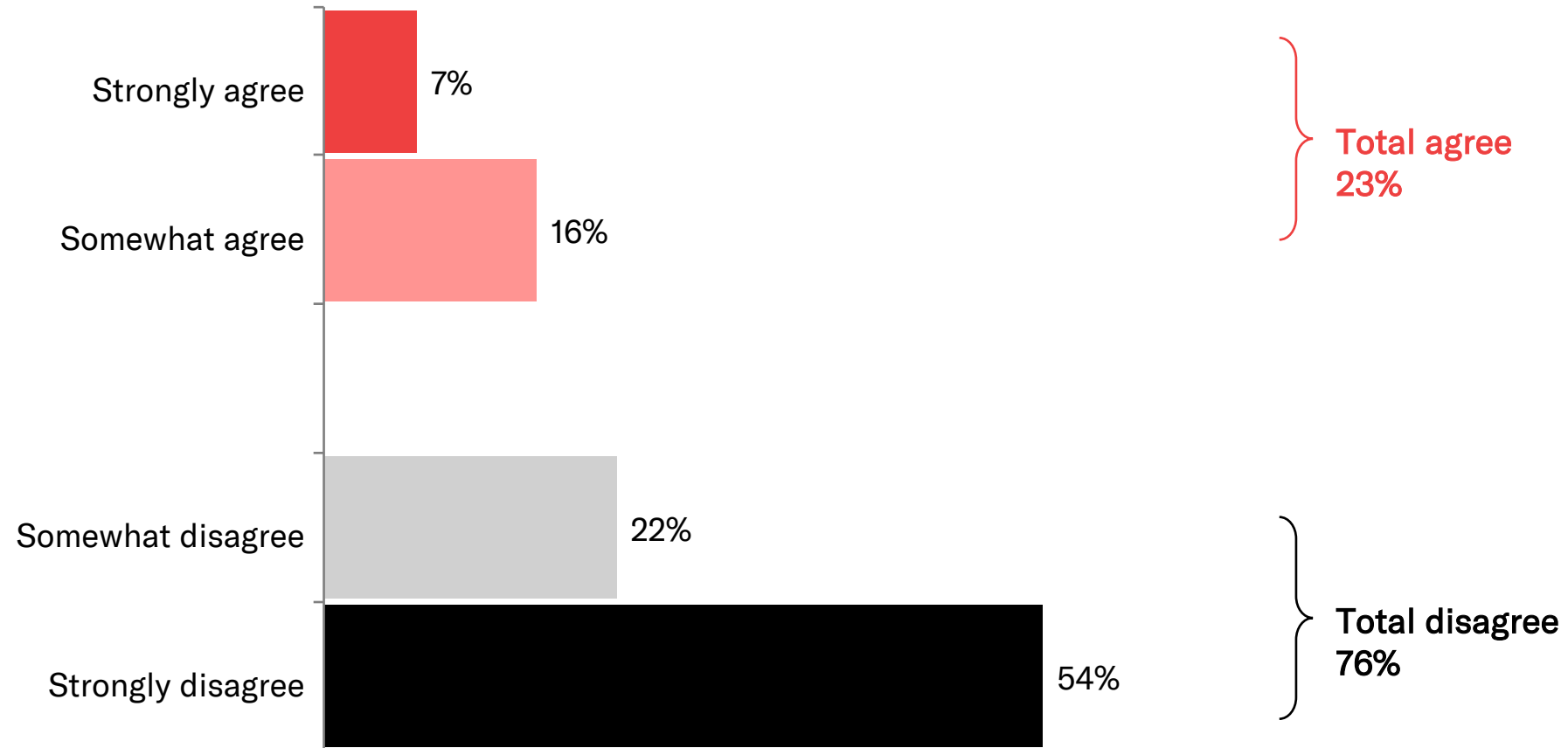
Nearly all voters think regulating government use of face recognition surveillance technologies is important.

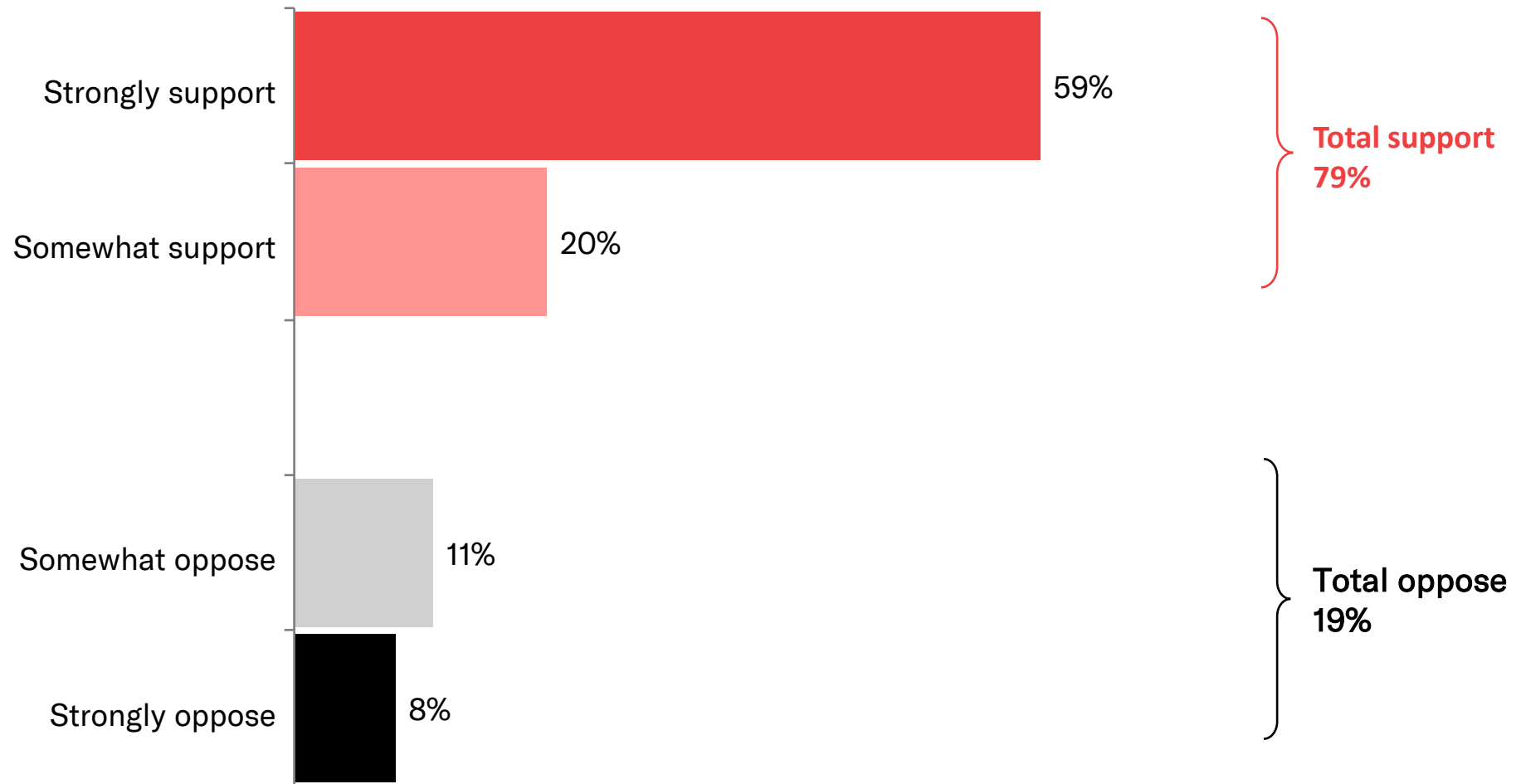
Most voters do not agree that government should be able to monitor and track people with technology.

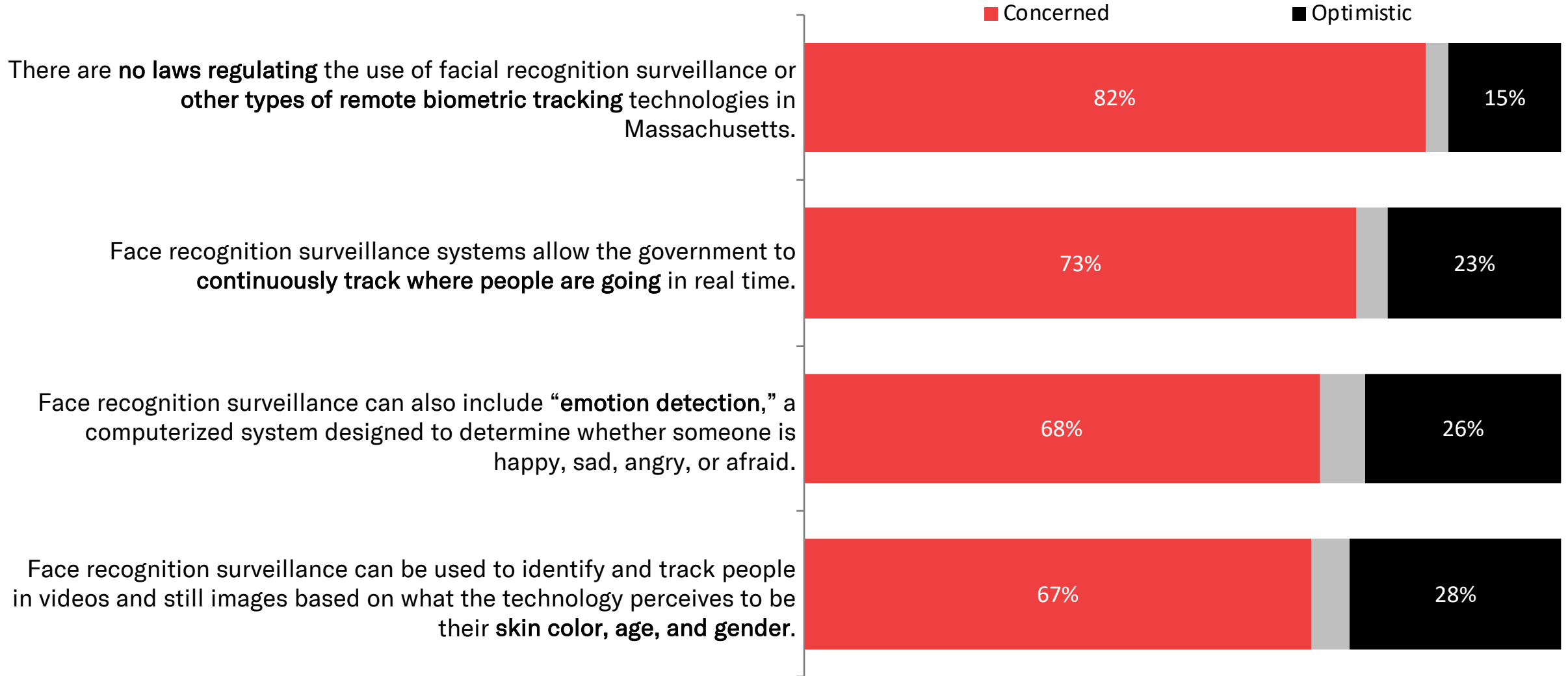
Nearly 8-in-10 support a moratorium on government use of face recognition surveillance.
