

## Special Weapons and Tactics Team (SWAT)

On Friday January 17, 2014 the NEMLEC SWAT Team was activated to assist the Peabody Police Department with serving a high risk search warrant. The team was instructed to stage at the Peabody Police Department at 0500 hours. Upon my arrival at the staging area I was briefed on the case background by Det. Eric Ricci and Off. Mark Saia of the Peabody Police Department. Det, Ricci informed me that as a result of a narcotics investigation he had obtained a no - knock According to Det. Ricci the main target of the search warrant fol Monroe Court Det. Ricci indicated that numerous controlled investigation was transactions had been conducted using a confidential informant (CI) and that all the transactions took place in the basement of Monroe Court. The entrance for the basement was a door located on the rear of the home (side 2). Det. Ricci also informed me that during one the was in possession of a handgun and when the CI questioned if the handgun transactions took the magazine out of the weapon and showed the CI the bullets. was real, criminal record consisting of numerous A&B's and Assaults with a Dangerous Weapon (handgun). The target location a Monroe Court is a "row house" style structure with lives at the location with his mother and younger sister. approximately six units.

After the team leaders and vehicle operators conducted a surveillance drive by of the target location an operational plan was developed. The plan called for both the Alpha and Bravo Teams to make entry into the target location. The Alpha Team upon approach from the vehicles would split into two teams with one team making entry into the front door (1 side) and the other half of the team making entry on a rear (2 side) kitchen door. The Bravo Team would make entry into the basement from a ground level door located on the 2 side of the structure. The Delta Team would secure the perimeter and provide an over watch.

After the team was briefed on the operation, team assignments were given and then several rehearsals were conducted along with a final brief back of all team assignments. At 0600 hours the teams loaded up in assigned vehicles and traveled a predetermined route to a forward staging area. Once at the forward staging area final preparations were performed and at approximately 0605 hours the teams proceeded to the target location. The order of vehicles was Bravo, Alpha and Delta. The Bravo Team conducted the reverse "five count" for the operation.

Once the teams arrived at the target location they dismounted and initiated the service of the warrant. The Alpha Team broke into two elements with Alpha (1) setting up on the main front door (1 side) and Alpha (2) setting up on the rear kitchen door (2 side) and the Bravo Team setting up on the basement door on the ground level (2 side). Upon the command of the Alpha Team leader the entry teams conducted simultaneous breaches. Once inside the Alpha Team made contact with suspect, so on the second floor. Was handcuffed by Operator Rego. In a second floor bedroom a male party, were located by Operators Fay and Dicker. Both parties were ordered to the ground and was handcuffed. The Bravo Team made entry into the basement without incident, locating no suspect(s).

A secondary search of the house was conducted, which included the search of an attic area and also a locked second floor bedroom closet door. After the secondary search was completed the house and all detained parties were tuned over to the Peabody Police Detectives. After clearing the scene the team returned to the Peabody Police Department where a debrief of the operation was conducted. The team was then dismissed. The hours of the operation were 044 – 0800 hours.
