

On Wednesday 1/22/14 at 1000 hrs. Billerica PD contacted me regarding a suspected home invasion that may occur in their town. I attending a meeting at Billerica PD at 1200 hrs. on the 22nd and discussed the intelligence that was provided by a CI.

The CI provided information that an individual known to him is planning a home invasion at Alexander Rd. in Billerica, MA. The CI went on to state that a of Martin St in Lowell was the primary suspect planning this home was a white male, described as approximately 6'1" tall and weighing invasion. mother lives at Hickory lane in Billerica and he is known to the 210 lbs. Billerica PD from a reported incident on the prior evening at 3 Hickory Lane. It was was attempting a larceny from his mothers home. According to reported that Mas a drug problem. was said to be the reporting party and CI operating a brown 2001 Chevy Venture Minivan MA939XG6. has a prior was enlisting the assistance of others to record of drug and M/V charges. execute the home invasion and this is how the CI gained knowledge of his plan. planned to do this proposed home invasion over the next couple of days. The location Alexander Rd was said to have a significant quantity of marijuana and cash on hand.

NEMLEC SWAT north team was immediately put on call for a possible response to Billerica while more intelligence was being gathered. At 1900 hrs. on Wed. 1/22/14 it was decided to call out a 6-8 man team to support Billerica surveillance operations at Alexander Rd. NEMLEC SWAT command staff members stayed actively involved in gathering additional intelligence from meetings with Billerica detectives and their command staff while the team was deployed close to the target location. NEMLEC teams remained in place until Thursday 1/23/14 at 2300 hrs. at which time Bllerica PD had determined the threat had been mitigated by contacting the residents at Alexander Rd. and CBI detectives arrested the suspect and an associate on unrelated charges in Lowell.
