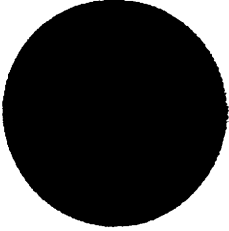

SUBJ: SWAT callout to assist Somerville Police Department

On March 25, 2013 the NEMLEC SWAT Team received a call to stage at the old Star Market parking lot located at [REDACTED] Broadway Somerville, Massachusetts for an armed barricaded subject. Upon our arrival we learned the Somerville Police received a call for an armed home invasion at [REDACTED] Derby Street apartment [REDACTED] Somerville, Massachusetts. The Somerville Police responded and immediately apprehended one [REDACTED] male suspect ([REDACTED]) who was in possession of a handgun that turned out to be an air gun. The second suspect had fled into the Somerville Housing projects and was last seen fleeing into [REDACTED] Memorial Road. The building is an eight unit apartment building consisting of three levels. The Somerville Police surrounded the building and later believed the suspect enter the building and did not come out. Due to this information the Somerville Police secured the perimeter and contacted NEMLEC.

At this time operators started to arrive on location and an immediate action team was being organized. While making assignments and gathering equipment we learned the Somerville Police had located the second suspect [REDACTED] who was also placed into custody. [REDACTED] was hiding in apartment 37 and the Somerville Police located a loaded 45 caliber handgun with a laser sight hidden under a mattress. The SWAT Team stood by for further operators responding, debriefed and cleared the scene.
