

RE: SWAT Callout Newton March 31, 2014

On Monday March 31, 2014 at approximately 1330 hours the NEMLEC SWAT Team was activated to assist the Newton Police Department with the search for a carjacking suspect. The suspect had brandished a firearm during the theft of the vehicle in Newton then had attempted to run down two uniformed Newton officers. The Newton officers fired several rounds at the suspect/motor vehicle during this confrontation. The SWAT Team was instructed to stage at the [REDACTED] Commonwealth Ave.

It was learned a short time later that the suspect, [REDACTED] had been involved in a second carjacking in Billerica, a subsequent car chase in Carlisle lead to a violent confrontation where the suspect and two Carlisle police officers exchanged gunfire. It was at this point that the SWAT Team was instructed to stage at the Billerica House of Correction and wait for possible deployment to one of the surrounding communities. The suspect was eventually taken into custody in Bedford after being involved in a motor vehicle crash.
