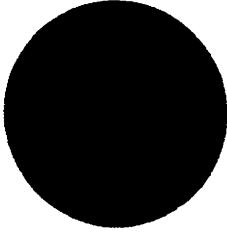

RE: SWAT Callout Tyngsboro May 3, 2014

On Saturday May 3, 2014 a limited element of the NEMLEC SWAT team was requested to assist the Tyngsboro Police Department. Tyngsboro Police requested assistance with an event being organized by the [REDACTED] Motorcycle Gang. The event would consist of a procession of approximately 150 bikers traveling through Tyngsboro to The American Legion Post on Pawtucket Boulevard. Upon reaching the American Legion the [REDACTED] would conduct a recruitment drive and pig roast. Due to ongoing and recent altercations between the Hells Angels and other outlaw motorcycle gangs combined with the gang's well documented history of violence a strong police presence was required. As a result, a rapid response team of SWAT operators would be deployed nearby to the event.

The team was instructed to stage at the Tyngsboro Police Department at 0900 hours. The team was briefed by Sgt. Mark Bourque on the operational plan which consisted of the Tyngsboro Police Department, the Mass. State Police Gang Unit and CAT team providing a high visibility near the American Legion. The NEMLEC SWAT team would stage nearby should an incident occur requiring the teams response. The team would be staged at the Tyngsboro Country Club.

Through the duration of the event there were no major incidents requiring a SWAT response. At approximately 1500 hours the team cleared the location after it was determined that a small number of people remained at the American Legion. The SWAT team returned to the Tyngsboro Police Department and cleared. The hours of the operation were 0800- 1600 hours.
