On Saturday June 8, 2013 at approximately 1530 hours the NEMLEC SWAT team was activated and instructed to stage Orchard Street Watertown, to assist the Watertown Police Department with an armed barricaded male. Upon my arrival at the staging area I learned from the Watertown PD that the suspect in the barricade, DOB known to the police as a result of the Watertown PD responding to numerous domestic disputes at his home. At approximately 1445 hours on this date (June 8th) a realtor and a carpenter had home to change the door locks as part of a divorce settlement that agreed to. When the carpenter attempted to change the locks, took his power drill out of carpenter's hands and put it to the carpenter's neck. then retreated into his house telling the carpenter and realtor that he was going to get his gun. The Watertown PD was contacted at this point and responded to the address and set up a perimeter around the home and attempted to make contact with was described as a white male 6'4" 200 pounds. Watertown PD also indicated that could possibly be bleeding around his abdomen as a result of some recent surgery. There was no record of being issued an LTC according to Watertown PD records.

Once on scene at Carroll Street I met with Lt. Chaput who informed that Sgt. Grady from the Watertown PD had made contact with over the phone and that Sgt. Grady was being coached by NEMLEC CNT member Sgt. Herrera. At this time an immediate action team (Alpha) was deployed to the front of the house (side 1) along with a perimeter team (Delta) that had been put into place to relieve the Watertown patrol officers. Sgt. Grady had off and on contact with the suspect over the next 30 minutes. At some point informed Sgt. Grady that he was going to come out the rear door (side 3) and sit on the back steps. The Alpha Team moved up to 3 side and when the suspect came out holding a cell phone he was given voice commands by Operator DiChiara. The suspect failed to follow the commands and the Alpha team had to move up and take the suspect into custody. While the suspect was being taken into custody he made a statement to the members of the team to, "just let me sit down and you can shoot me". Once the suspect was in custody several operators; O'Leary, Max, Dicker, and Banosian cleared the first floor and the following operators cleared the basement; Frechette, Chaput (MAO), Fagan

(MSO), Gianino (MSO) searching for any other parties in the house. Once the house was cleared and the scene was safe the suspect was turned over to Watertown PD. The team then returned back to the staging area where the callout was debriefed. The team was then dismissed. The hours of the operation were 1530 - 1930 hours.
