

On Friday August 3, 2012 at approximately 1130 hours the NEMLEC SWAT team was activated to assist the Lowell PD with a barricaded subjects at [REDACTED] Lane Street. The team was instructed to stage at [REDACTED] Smith Street.

Upon my arrival at [REDACTED] Lane Street I made contact with the Lowell PD OIC, Deputy Ryan. Deputy Ryan informed me that Lowell officers had responded to [REDACTED] Lane Street for an armed robbery. The victim had informed the Lowell officers that he had been robbed at gun point in the rear stairwell near the second floor. The victim indicated that there were two suspects and one of the suspects had a handgun. After robbing the victim the suspects fled to the third floor. The information that Lowell PD had obtained indicated that the third floor was a single apartment and it was vacant. Lowell PD had set up a perimeter around [REDACTED] Lane Street.

Sgt. Fay was designated as the team leader for the operation and was instructed to form an immediate action team. The following operators were assigned to the IAT;

As the SWAT team was moving into position the two suspects, [REDACTED] exited the building and were immediately taken into custody by Lowell PD officers with the assistance of Operators Keins and Dorsey.

After the suspects were taken into custody the IAT made entry into [REDACTED] Lane Street and performed a systematic search of the entire building. The team had to breach the door on the floor apartment to make entry. No further suspects were located. See Sgt. Fay's after action report.

After de-briefing the incident the team was dismissed. The hours of the operation were 1130-1530 hours. It should be noted as a result search of the 2<sup>nd</sup> floor apartment by Lowell Pd detectives a 9mm handgun and a large amount of drugs were located.
