



RE: SWAT Callout Warner Street Gloucester

On Saturday September 7, 2013 at approximately 0150 hours the NEMLEC SWAT Team was activated to assist the Gloucester Police Department with an armed barricaded suicidal male. The team was instructed to Stage at Warner Street. Upon my arrival at the staging area I made contact with Sgt. Joe Catarim of the Gloucester PD. Sgt. Catarim informed me that the subject, had recently lost his job as a security guard at and had been in contact with his social worker earlier in the evening telling her that he was going to harm himself and that he would challenge the police if they got involved. The had also informed his social worker that he would had access to a firearm by tomorrow. It was believed that was armed with a knife at this time.

The Gloucester PD responded to Warner Street and secured a perimeter around the house. Numerous attempts by the Gloucester PD to contact in his third floor apartment were met with negative results. It was believed that was inside the apartment as his vehicle was parked outside. The first and second floor apartments were not occupied at this time. The Gloucester PD indicated that would be taken into custody under a section 12.

It was at this this time that an immediate action team (Alpha) was formed and entered the home through a door on the 4 side. As the Alpha Team was making their way to the third floor, they observed that the second floor apartment was unsecured. The Alpha Team made entry into the apartment and cleared it. The Bravo Team made entry into the 1 side and moved to the third floor. The Delta Team secured the perimeter. Once all the teams were in place CNT member Ricci by phone, this was met with negative results. Negotiator Ricci then attempted to contact utilizing the PA system on the Bearcat. No contact was made and it was attempted to contact decided that negotiator Ricci would move to the third floor and attempt to make contact with utilizing a bullhorn from outside the apartment door. Shortly after negotiator Ricci announced his came to the apartment door was given verbal commands by members of the Alpha Team then was taken into custody and handcuffed by Operators Cogswell and Saia then turned over to the Gloucester Police and subsequently transported to the hospital. A secondary search of the apartment was conducted by members of the Alpha and Bravo Teams. After securing the apartment it was turned over to the Gloucester Police. The SWAT Team then assembled outside the residence and conducted a debriefing of the operation. The SWAT Team was then dismissed; the hours of the operation were 0130 – 0530. It should be noted the Gloucester Police recovered a large hunting knife from the suspect's apartment.
