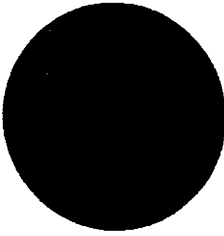

After Action Report

On Monday September 9, 2013 at approximately 1400 hrs. the RRT and SWAT responded to Forest St in Dunstable for the report of a missing 57 year old male who had a history of depression and suicidal thoughts.

[REDACTED] Forest St Dunstable, MA had been missing from his home since late the previous evening. He apparently left on foot. Multiple K9 resources had already been deployed to search the area and were unsuccessful so far. The MSP air wing resources were called to search from the air. We deployed ATVs, mountain bikes and personnel on foot to conduct line and grid searches of the area to include residences and out buildings.

At approximately 1630 Dunstable PD received permission to enter the residence at [REDACTED] Forest Street, which was For Sale and unoccupied. Dunstable Officer Chaprales and members of NEMLEC and MSO units on scene entered to conduct a search. The subject, [REDACTED] was found deceased on the floor in the garage with self inflicted wounds. EMTs Crabtree and Hackett pronounced [REDACTED] dead at 1704 hrs.
