PLAINTIFFS' MOTION FOR PRELIMINARY INJUNCTION

Plaintiffs American Civil Liberties Union of Massachusetts ("ACLUM") and American Civil Liberties Union ("ACLU") respectfully move for a preliminary injunction against the Boston Police Department (the "BPD") and Commissioner William B. Evans (collectively, the "Defendants"), requiring Defendants to produce certain public records pursuant to the Massachusetts Public Records Law (the "MPRL"), G.L. c. 66, § 10.

Following a multi-year effort to obtain information about police-civilian encounters in Boston, a recently released analysis of data culled from BPD records of its officers' interactions with civilians between 2007 and 2010 revealed that BPD has engaged in racially disparate treatment of Blacks and Hispanics. In September 2014, Plaintiffs submitted a public records request for additional data from the BPD that they needed to determine if disparities have persisted after 2010.

Defendants do not dispute that the requested records are public and have not articulated a valid basis for withholding the documents that Plaintiffs seek. Yet, more than 11 months after the Plaintiffs' requests, Defendants have not produced the requested records. Defendants' decision to withhold the requested records without a valid justification is a violation of the MPRL and has harmed Plaintiffs and the public.

In support of this motion, Plaintiffs rely on their Verified Complaint, Memorandum in Support of Motion for Preliminary Injunction, and Proposed Preliminary Injunction.
